
# **Bois Blanc Township Community Survey**

The Bois Blanc Township Planning Commission initiated an update of the Township Master Plan in 2020. Public input is a key element of developing a community master plan. Considering the seasonal nature of the Island community, the high percentage of seasonal residents and absentee landowners, and the COVID Pandemic, the Planning Commission chose to use a web based survey to obtain opinions and input into the future of our Island. The community highly values the opinions of those who choose to live here full-time or part-time. The input will be used to develop goals, objectives and a future land use plan for our Township.


The survey was developed by the Township Planning Commission in 2020. With the assistance of Richard Deuell, Planning Consultant, the survey instrument was completed. The survey was posted on the Survey Monkey website and printed copies were made available at the Township Hall. A notice was inserted in the 2021 winter tax bill with a total of XXXXXXX landowners being contacted. There were 245 surveys completed.


# **Community Character and Preferences**

When asked how satisfied citizens are with Bois Blanc Township as a place to live or own property, 39% selected very satisfied and 51% satisfied, see Figure 1.



The survey inquired into the importance of protecting resources on the Bois Blanc Island. Over 80% of the respondents considered quality of groundwater and water quality of Lake Huron and island lakes very important. If the "very important" and "important" selections are combined for each resource type, all were 90% or more, see Figure 2. When asked if the Township should help protect the resources identified as very important a **majority (86%) answered yes**, 3% selected no and 11% don't know/neutral. A solid majority of respondents (86%) feel preserving large tracts of forests and wetlands is important, Figure 3.






In order to identify important components of the Island community and what should be maintained and improved, a question was used to determine how important aspects of community character were to people deciding to live or own property in Bois Blanc Township. Living near water, living in the woods, clean air, rural/remote living, isolation and solitude and friendly neighbors all had combined percentages of "very important" and "important" above 80%.

# **Community Planning and Development**

This question was designed to evaluate citizens' preferences towards planning and future development. As shown in the table below, the survey found a clear majority (62%) support a policy of Planned and Limited Growth.




There was a spread of responses concerning the Township's efforts to guide and direct growth. Thirty-six percent considered the Township's efforts satisfactory, while 29% rated efforts good or excellent and 36% considered efforts as fair or poor. As far as the overall current development in Bois Blanc Township, 64% agreed it is "about right."

Forty-nine percent felt the Township should promote community services such as food systems, grocery, fuels, & transportation. As new retail/services develop 61% of the respondents prefer standalone businesses at major intersections. Whether the Township should promote tourism/recreation, 47% selected "no" and 25% chose "don't know/neutral."

The survey assessed how much of a problem several issues are in Bois Blanc Township. The table below shows the results of the question. Items with 50% or more combined "major issue" and "moderate issue" are *Changing Island culture/increase population, Access to medical and emergency services, and Ferry Service.* Other issues with higher percentages are *Substandard Septic Systems, Use of travel trailers for seasonal housing, and Lack of recreation management on DNR and Park Service lands.*

Blight is a very localized problem, if your neighbor 's property is cluttered with "junk" then it's an issue. Less than one quarter of the responses were "yes" for blight being a problem, whereas, 34% chose "no" and 42% "don't know/neutral." With 24% expressing a concern, the Township should consider identifying problem spots and addressing blight clean-up.

#### **Community Services and Facilities**

Thirty-six percent of the respondents feel Bois Blanc Township is responsive to their needs, and 46% selected "don't know/neutral." A majority (64%) selected "yes" that Bois Blanc Township should upgrade its website to better inform citizens of township activities, disseminate information, and provide township forms.

The survey found people are generally satisfied with road maintenance and road conditions in the Township, 63% are satisfied with 22% having concerns. Road segments that respondents would like to see improved and other road concerns are located in the appendix. Only, 21% find improper use of private roads a problem, 30% selected "no" and 48% chose "don't know/neutral."


Services with satisfaction percentages 50% and higher are Fire Protection, Road Maintenance, Bois Blanc Airport and Ferry Service.



## **Profile of Survey Respondents**

Year-round resident homeowners accounted for 14% and seasonal residents 53% of the survey responses while 24% selected "vacation or visit less than one month" and 9% "non-resident." Peak months for seasonal residency are June, July and August and September with May and October also have higher usage. Over one third of the survey respondents have owned property in the Township for more than 20 years and 19% having owned property their entire life. Three percent of the respondents do not live in the township.




## **Property Information**

Over 50% of those who responded own waterfront property in the Township. The next highest category is "cabin in the woods" at 21%. When asked if the property is leased or rented, <u>eight percent</u> rent on a weekly or by the day basis. Most of the respondents

own five acres or less with 38% owning 1 to 5 acres and 25% owning less than one acre.



#### Age and Household Information

The largest group at 51% was the 40 to 64 years age group. Forty percent of the survey respondents were 65 years and older. A majority of the respondents (51%) live in two person households. Only 23% of the households have children 18 years and younger. Fortyfour percent are retired. A mix of employment groups found 7% work on the Island and 43% work off the Bois Blanc Island, while 5% live on the Island and work remotely.



#### Comments

The survey provided several opportunities to comment. As stated previously, 36% of the respondents feel Bois Blanc Township is responsive to their needs, and 46% selected "don't know/neutral." This question provided an opportunity to comment about the Township, and 61 comments were received and can be found in the Appendix. A list of roads or road segments that should be improved is provided in the appendix. For the question about listing the three most important assets that should be preserved in Bois Blanc Township, there were 518 items listed. When asked to list three issues or concerns that should be addressed in Bois Blanc Township, there were 446 items. The following two pages word clouds for the assets and concerns questions. These are graphic representations, whereby the size of a word represents the number of times the word is mentioned in the combined responses. Finally, the survey provided an opportunity submit any concerns or suggestions that were not addressed in the survey. There are a total of 67 comments.
