Regular Meeting January 13, 2021

Department Reports:

Marina: Guests present for this meeting were Andrea Brush (Andy), Office of Passenger Transportation (OPT) — MDOT, Valerie Schultz and Jean Ruestman — MDOT. Explanation of the Federal Ferry Boat Program funds was offered by Andy Brush along with a brief history of how we get them, how we have tried to utilize them and why we have not been able to. The only thing eligible for these funds to be used on would be the public dock on Bois Blanc Island. OPT has proposed a way to flex the funds to the Federal Transit Administration and enter into a contract with the Township as a sub-recipient. We would be assigned a project manager to assist us and make sure all rules are followed. In this way the approx.. \$30,000 per year would be available for qualified projects. Discussion. Motion was made by A Kennedy, 2nd by L Sullivan to formally express our interest and move forward with MDOT OPT to make the Ferry Funds available for marina projects. Some follow-up items were discussed. 1)Minutes including this motion will be forwarded to Andrea. 2)Consider a project team to work on the project description. 3)Designated contacts are Brent Sharpe and Anne Kennedy. 4)Copy of the reports supplied to the Federal Govt by Plaunt Transportation will be requested. 5)Future reporting should probably come via the township.

Airport: Brent was just out there and things appear to be in working order.

Fire: Brandon reported that they have been busy with coordination with 911 and the hospital in St Ignace. All FD/EMR's have gotten their first vaccine and the second will be coming soon. CPR training class has been done. EMR class starting (5 members) in Jan and will run into March. It will required a few trips and possibly overnights off island for practacles. School asked them to help with an ice rink. Now we just need colder weather to solidify the ice!

Law: Still waiting on Mackinac County for the new contract. Reimbursement invoice for 2020 has been sent.

Cemetery: Nothing new.

<u>Parks and Rec</u>: Nothing new. Will need to put a timeframe in place on the Bright Water Park project to get the work completed.

<u>Planning</u>: No report from the last meeting. Brent Sharpe brought up that the planning commission should be aware of current changes that have been made by the health dept. regarding septic systems and that some of our current lot sizes will not accommodate a septic field. We may need to look at how our zoning may need to be changed moving forward.

Transfer Station: No report

Zoning: There have been no applicants for the open position yet.

<u>Maintenance:</u> Michelle is keeping up with the cleaning in the wagner room and airport that needs to be done right now.

<u>Health Committee:</u> Straits hospital has notified us that at least through the winter everything would be done through tele-med. Dr Lejay is willing to take on the island residents as patients, so she can offer tele-med, but legally before she can do tele-med with any patient she would need to physically see them once first.
