

Holland Engineering provided 3D images of the ten properties adjacent to the Akright property. These images provide a vantage point of the proposed tower from ground level and at 100 feet above ground level at each property. The 3D images are included within Appendix A and the view-scapes of the ten adjacent properties show no visual impact of the proposed tower from the ground. Even at 100 feet above ground level, the visual impacts are minimal.

Holland Engineering also provided a 360-degree view of the proposed tower on the Akright property at 130 feet above ground level. These images are included within Appendix B and show that no adjacent property homes or dwellings can be viewed from this vantage point.
