within the road right-of-way of Huron Avenue and the Beach Park by defining terms, prohibiting certain structures, prohibiting certain non-conforming structures from being rebuilt, allowing certain repairs or maintenance to lawful nonconforming stairs or stairways, allowing new stairs or steps meeting certain construction and standard requirements, notification of outside agency permitting requirements, the option of a survey requirement, and exceptions.
